A MESSAGE TO THE MEMBERSHIP FROM THE 2000-2001 BOARD

Membership Survey Results from Spring Event, April 2000

Total Respondents: 105

47% Said that raising funds for Scholarships was extremely important and preferred that members be "assessed" a scholarship contribution in lieu of a labor-intensive fundraising event.

33% Said that raising funds for Scholarships was somewhat important and they would be willing not only to contribute toward a "scholarship assessment" but also to volunteer in a fundraising event.

10% Said that Scholarships were somewhat important, but they were not willing to contribute any time or additional resources to this purpose.

10% Said that Scholarships were NOT important to them at all.

Of the 80% in favor of a "scholarship assessment" or contribution, respondents suggested a MINIMUM amount of \$25-\$30 (with an option for those wishing to make a greater contribution—with a greater tax deduction).

The Board has carefully considered these results. THE REALITY IS THIS—if every single member contributed at least \$25 to the Scholarship Fund (line item on the Membership Form included in this *Messages*), we would collect nearly \$8,700! This figure represents more money than any single fundraising event this organization has seen in its history—and only with a lick of a stamp! Members benefit because your entire contribution is tax deductible (not just \$5.00 from an event ticket price), which is something we're all concerned about as we enter the last quarter of the 2000 tax year.

While this represents a significant departure from our traditional fundraising activities, the Board encourages our membership to seriously choose this alternative. Considering our busy lives and limited time, this alternative makes good business sense!

Dan Corson, *Preserving Boulder's Community Character*.

Attorney, professor, historian, author and city councilman, Dan Corson holds numerous degrees and is involved in many civic and community activities. A CU Law School graduate, he "recovered" from a successful law practice by obtaining a master's degree in history. He has served on and been chair of many boards including Historic Boulder, Boulder Landmarks Advisory Board, Boulder Planning Board, Colorado Preservation, and Boulder Shelter for the Homeless. Since 1998, he has been the Colorado Historical Society's Local Government Liaison Officer for Historic Preservations. He has published articles on architecture and historic preservation, and co-authored a book with *Dr. Thomas Noel*, **Boulder County: An Illustrated History**. Dan is a relative of William A. 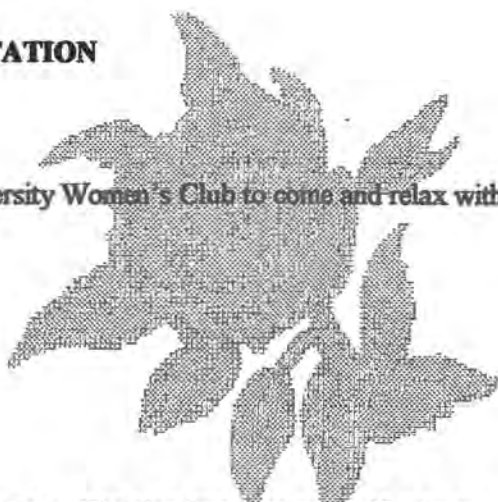
We usually present the Margaret Willard Award at this tea. However, no nominations were received from members this year, so there will be no award presentation.
