Dorothy Mandel has graciously consented to present a program at her home to the UWC entitled An Introduction to Woodcut Printmaking from the Artist's Studio at which time she will demonstrate the makings of a woodcut and have her prints on display. Dorothy Mandel has won numerous awards for her woodcuts and has been commissioned for various works including a poster of Chautauqua Auditorium designed for the 1981 Colorado Music Festival, which many of you will remember.

As a child, Dorothy Mandel's natural artistic talent was nurtured by her grandfather, a cabinetmaker who also delighted in creating inlaid-wood pieces of art. Even today she prefers the media of wood - the challenge of merging unique grain patterns with the design of the print. She does use a press for printing but painstakingly hand rubs the wood block, thus bringing out the subtleties of the grain.

Dorothy Mandel is not only an artist but also a wife, mother, grandmother, and author; she is finishing a biography of Angna Enters. She has also been invited to China for a three-week visit as a Citizen Ambassador with a professional arts and crafts delegation of Person to Person International.

The UWC members are indeed lucky to have this opportunity to meet such a lively and personable Boulder artist. Any prints sold during this program will benefit the Club since Dorothy Mandel has generously volunteered to contribute 25% of all proceeds to our Women's Scholarship Fund. We will meet at 9:30 promptly at the beginning of Linden just west of North Broadway to carpool up to her house since parking in Pine Brook Hills is limited. If for some reason you have to drive up to her house, the directions are as follows: Drive west on Linden from North Broadway about two miles into the foothills and Pine Brook Hills. At the first junction, go left on Timberlane.
At the second junction go right on
Linden. At the third junction,
keep left to Timberlane. At the fourth junction turn right onto Pine Tree Lane, continue right onto Balsam until black mailbox on the left - 355 Mandel. Drive up to the house at the TOP of the driveway.




