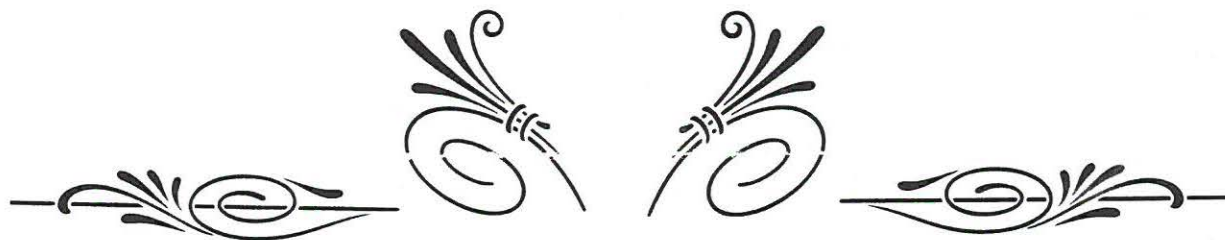

PROFESSOR PRESCOTT'S ADDRESS TO THE OCTOBER UWC'S PROGRAM

Anyone knows that a politician cannot win on a negative platform: don't do this and avoid that. But according to David Prescott, Professor of Molecular, Cellular, and Developmental Biology, who spoke to the UWC on October 28, one must avoid a good many temptations, especially in affluent societies, in order to maintain a high degree of wellness.

Genetic considerations are secondary to environmental factors in improving the quality of one's life and in slowing down the aging process. There are external factors that one can control, most of which are things to avoid: smoking of any kind, smoked foods, fats of any kind, foods cooked at a very high temperature other than for a brief time, exposure to the sun, exposure to hazardous material, excess calories, and a surprising collection of foods that contain carcinogenic substances, such as raw mushrooms, alfalfa sprouts, and sometimes peanuts.

With the help of slides and with current medical information, Professor Prosecute enlightened and entertained a group of about 60 women with stories and hard scientific data. The one thing not to avoid, of course, is exercise.

The Feminist Legacy of Karen Horney

Marcia Westkott

In the 1920s, Karen Horney created a tempest in the psychoanalytic world by taking issue with Freud's psychology of women. It is not "penis envy" that accounts for girls' jealousy of their brothers, she claimed, but their actual experience in the family, which treats all females as inferior and thus makes the advantages of being male only too obvious.

Horney's later work expanded on this view of the family in modern society as a "hot-house" for the development of inner conflict. She herself insisted, and most previous commentators have agreed, that her later theories apply equally to males and females. Marcia Westkott argues, to the contrary, that Horney's later work continues to have special relevance for women. From this perspective, Westkott builds on Horney's ideas to create a new theory of women's psychological development, which she relates to recent feminist writings on female anger, dependency, and altruism.

According to Horney, the central psychological conflict of our age is between dependency and ambition. Westkott extends this idea to describe a typical woman in Western society, one who is devalued and sexualized within the family as a child and in the larger society as an adult, and who seeks to avoid further humiliation by making herself as lovable and attractive as possible and by adopting the culture's standards of behavior and appearance as her own. But, says Westkott, her efforts to achieve feminine perfection are sabotaged by underlying rage that can take many forms, from injured innocence to hostile competition with others.

Only by abandoning these external standards and rediscovering the potential of their real and imperfect selves, argues Westkott, will women be able to free themselves from the conflict between sweet compliance to others and the rage to triumph over them in order to realize a new female heroism. By interpreting Horney's work as a historically based psychology of women, Westkott has made a new and important contribution to contemporary feminist theory.

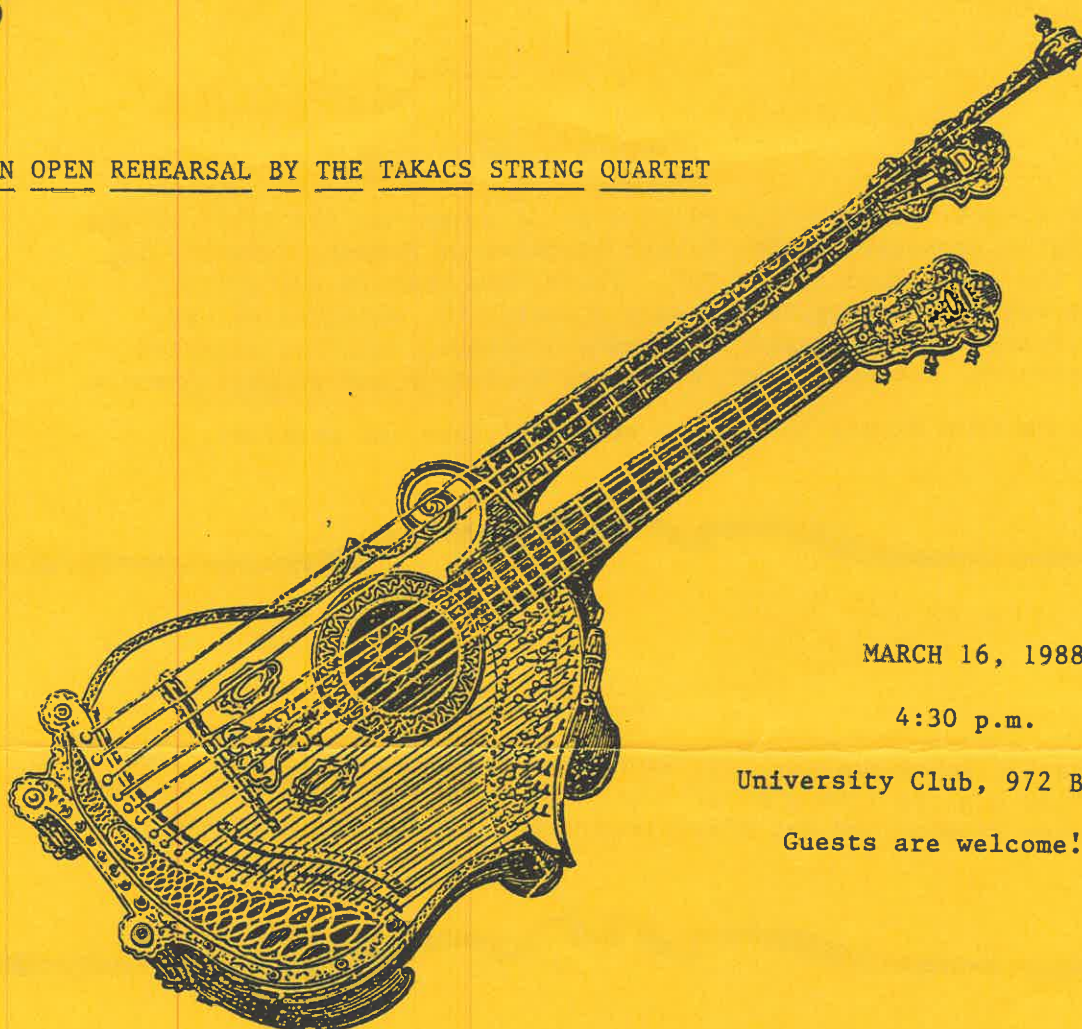

THE UNIVERSITY WOMEN'S CLUB--A REMINISCENCE
by
Florence Grieder

Since I was asked to write a short informal history of the University Women's Club, I have given some thought to it and am impressed by its long record of continuity and good works. Through depression, war, and radically changing times it has remained a vital part of the University. Mrs. Norlin, wife of President George Norlin, would be pleased. In 1919 she invited a few wives of faculty members to the president's home on the campus (now Koenig Alumni Center) to discuss the idea of an organization for faculty wives and women faculty members to enable them to become better acquainted. It was immediately accepted.

The members met informally in homes until 1924, when they officially organized and framed a constitution. Mrs. James Willard became the first president. The constitution reaffirmed the purposes: to promote friendship among the members and to foster community spirit. It has served those purposes these many years.

When my husband and I came to the University in 1940, the enrollment was 4,200, and the population of Boulder a mere 13,000. The faculty was small enough that the president's wife, the lovely Amy Stearns, called on all the new families. I well remember when she called on me. She came beautifully dressed, with hat and gloves, and left her card. She found me breathless and unkempt, as our frisky Irish setter had just taken me for a run. Our furniture, coming by train from Buffalo, had not yet arrived. The plumber had shut off the water for repairs. None of this mattered. I soon felt welcomed and comfortable. When I asked if there was a newcomer's club here, she said, "No, but that's a good idea." Early in 1941 she organized the group, and many a longtime friendship was fostered in Newcomer's Club.

Our dean's wife, Mrs. Harl Douglass, took me to my first meeting of the Women's Club. It was customary for the deans' wives to do this for new faculty wives and was a very welcome gesture to new arrivals. The meeting was held at what was then the Student Union, later the School of Business, and now the Department of Economics. Meetings were held once a month on a Friday afternoon at 2:45. The ladies came dressed for the occasion, always in hats and gloves, the accepted accessories for afternoon functions. The president, Mrs. Arthur Cross, conducted the business meeting, which was followed by a program with a speaker and some music. The committee appointed for this meeting then served tea at a beautifully decorated table with the Club's silver, flowers, and tea delicacies. It was an honor when one was asked to pour. Members were informed of the meetings by a card each month.

Some of the customs begun in those early years were carried on. The Medical School wives were entertained, and the courtesy was returned. Each summer a party was given for visiting faculty--a tradition begun in Norlin's presidency and continued for many years. It was often a garden party at the president's home, attended by as many as 500 members and guests. The idea of changing it to an evening affair on the student union terrace came after one afternoon party when the temperature was 104 degrees.

The Christmas ball which we enjoyed for so many years started with the Club's December party. Later it became an all-University party, hosted by the president and his wife and the University Regents and their wives. It was a festive occasion held every year in the ballroom. The Club members took the responsibility for the planning, the orchestra, food, and decorations. Each year the decorating committee transformed the ballroom into a wonderland, sometimes with golden angels, stars, snowflakes, roses, and pine cones, or perhaps with a Mexican or some other theme. A large Christmas tree graced the stage where an orchestra had us dancing to the music of Glenn Miller, Tommy Dorsey, and others. The buffet table usually had as a centerpiece a beautiful ice sculpture, courtesy of the food service. Guests gathered in conversational groups to enjoy punch and many varieties of food.

We still look forward to the annual fashion show. The first one was held in 1956. Members wanted a show that would feature clothes for our ages and life styles, and that was how Brooks-Fauber presented it. There were clothes for all ages--one model was over 90 years, and all the models were Club members. The ticket price was \$2.50, and between 500 and 700 attended these early shows, many members bringing guests. One of our own members, Kay Yeager of Brooks-Fauber, coordinated the first show, and her husband, Jim "Gentlemen Jim" Yeager (CU football coach), delighted the guests with this witty commentary as models were presented.

Since the beginning, the University Women's Club has been cognizant of the needs of others--the community, the University, and the students--and has contributed in many ways. In the depression years of the Thirties, the Club's project was to supply milk for school children in Boulder. In 1934, 226 undernourished children benefited. During these years, the Club collected huge donations of clothing for Social Services. Federal relief had stopped and there was great need. A "donation party" was held where members brought their contributions and raised money during those years at annual Christmas carol concerts.

In 1943, the Club established a Norlin Memorial Ward at the Boulder County Hospital with four beds and took a special interest in its occupants.

World War II brought changes as many professors left to serve, and families followed. Those left had to put in many hours. Members contributed individually--sewing, knitting, driving for the Red Cross, and in other ways. With first aid classes and block drives, most kept busy in some way. The Japanese Language School took over our Faculty Club.

The Club has continued to serve the University by assistance in Norlin Library, in Wardenburg Health Center, and with scholarships. It has had to adapt to changing conditions of women, but still attempts to further its original purpose--promoting the bonds of friendship among its members.
