Since its construction in 1884, Cottage No. 1 has served as a gathering place for women. During the pioneer days of the University, the Cottage provided sleeping rooms for twelve women students, a bath, and an office for the chaperone. In 1902, Mary Elwell (later Mrs. Fred Folsom) described her life in the dormitory: "We had to furnish our own rooms. The only thing in them was a small stove for heat and to give us hot water. The University furnished a boy to carry wood and coal to the doors of our rooms . . . There was only one entertaining room, and it was very small. We used to fight to see who would get the room for the evening." At that time, the Women's League and the YWCA also used the Cottage and were soon joined by the Dean of Women who both worked and resided there. In 1924, the Cottage was renovated and became known as the Women's Building. It continued to serve as the only dormitory for women until the completion in 1934 of a larger women's residence hall. Since the 1930's, the Cottage has served as a center for various academic and administrative activities and is today the home of the Women Studies Program.

UWC has been supporting the efforts to renovate the Cottage since the announcement in 1992 that funds would have to be raised for serious corrective construction to insure a future for the building. Recently, a major contribution to the project was made by Commander James A. Woodruff, Jr., and that generous gift in honor of his deceased wife has resulted in the decision to name the cottage, "The Hazel Gates Woodruff Cottage for Women Studies".

Cottage No. 1, with its beautiful Victorian detailing, is certainly one of the most historically significant structures on the Boulder campus and is an important reminder to us all of the more than a century-long presence of women at the University of Colorado.

COTTAGE NUMBER ONE RENOVATION PROJECT

During its 76-year history, the University Women's Club has supported the University during many times of urgent need. Macky Auditorium, the CU Libraries, Wardenburg, the Alumni Center, as well as our own scholarships and loans, are programs that have benefited from UWC financial support. Since 1992, the UWC has participated in plans to rescue and preserve the 1884 site of the first women's dormitory. The CU Foundation must succeed in securing gifts and pledges of one million dollars by the end of 1995 to ensure that the project goes forward.

In February, 1995, the UWC Board voted to offer our membership the opportunity to participate in raising a targeted amount of \$25,000 toward that goal. By reaching this target, we expect to be able to name some portion of the building. We ask each UWC member to make a gift or pledge. A \$100 gift per family would allow us to meet our goal, but we welcome contributions in any amount. The CU Foundation will keep track of Club members' contributions and will mail acknowledgements to each contributor. 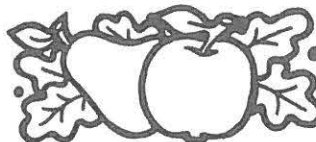

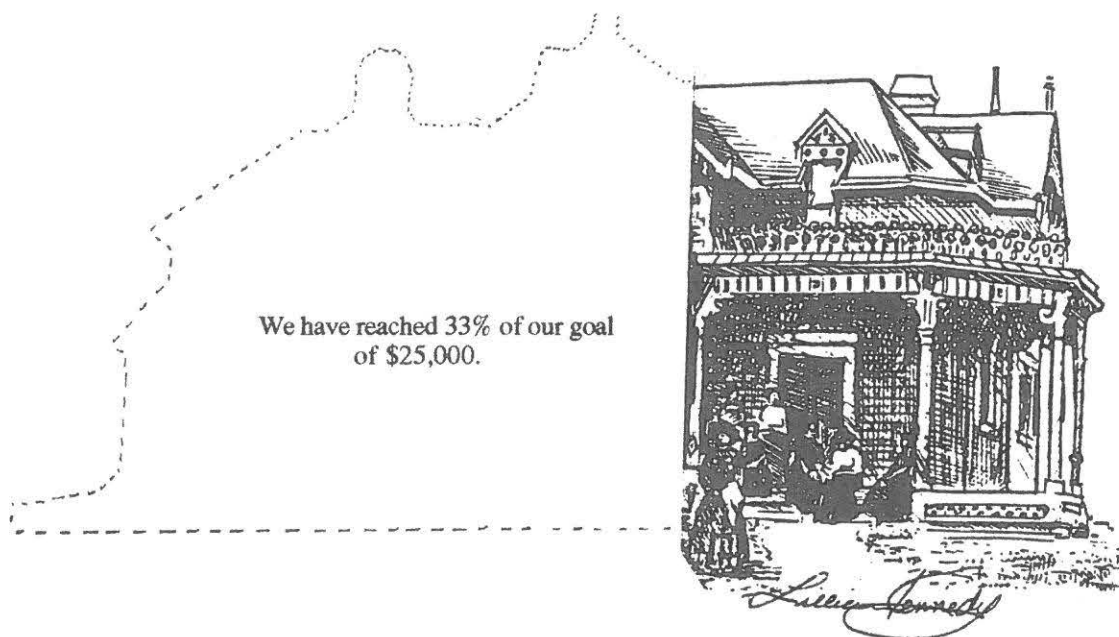
NORLIN LIBRARY BOOKFINDERS - A Report on a Service Project

In the early 70's a University Women's Club member, Sheryl Kuempel, saw the need for extra help to students in Norlin Library and started a program to recruit volunteers from the UWC. One of the first projects was initiated by Jean Clark and Jean Loeffler--a service of the Reference Department which they called "Bookfinders". From that time, spring and fall, based at a desk near the entrance to the 3rd floor stacks in Norlin, bookfinders have helped students and other library users to locate books and library facilities in the University. In recent years, bookfinders have had to expand their expertise by learning how to use CARL and CHINOOK and assist the students to access other computerized library systems. Their help is especially appreciated by foreign students and visiting faculty, as well as Boulder citizens. Bookfinders are people who enjoy books and students; each day is different.

Volunteers are always needed!! A bookfinder usually works a two-hour shift (sometimes longer on a busy day)--morning or afternoon--one day a week during the fall and spring semesters. New volunteers are trained by experienced volunteers with additional help from the Reference staff when needed. If you are interested in working as a bookfinder, please call one of the two people coordinating the schedule for the fall semester: Nancy McCaffrey - 442-1252 or Anne Goodnow - 447-0074.

Dear UWC Friends:

On November 1, I attended (along with 350 other women, including some from the UWC) the first Boulder luncheon of the Women's Federation of Colorado. As the organization presents itself, "the Women's Federation of Colorado was conceived as a statewide foundation in 1986 to develop resources and provide support for endeavors that promote the full participation of women and girls in society. Since its inception, more than \$1.6 million have been granted to community-based organizations that help women and girls throughout Colorado become economically secure." I write about this because I have been very impressed by the excellent work being done by another organization focused on the support of women (although on a grander scale monetarily than ours). The main speaker at the luncheon was Laura Liswood, who has been known for more than 20 years as an author and nationally recognized speaker dealing with women in leadership roles in politics and business. She told of her experiences interviewing 15 female heads of state and showed a video (a short and long version) of her interviews. The talk was very stimulating and exhilarating. I intend to keep an eye out in December for Ms Liswood's recently published book, *Women World Leaders*. In addition to the refreshing speech, four Boulder organizations were presented with checks for their excellent programs for women. This event had an electrifying air, and I recommend it to you for next year when the Women's Foundation presents an encore.

Another fascinating presentation was recently given by **Julia Frey** at the UWC November lecture luncheon. (Some of us are probably eating too much at all of these luncheons. I may finish this year looking different from when I began.) Julia gave us some insight into the life and work of Henri Toulouse-Lautrec. Her tribute to this creative and eccentric man was presented with slides and words beautifully woven together. I was captivated by Julia's "art" and hope to find time to tackle her book, *Toulouse-Lautrec: A Life*. **Toni Smokler** is to be complimented for her organizing this program.

Beverly Irons and her committee are moving along a path that will lead to a new fundraising event--a Book Fair/Sale to support women's scholarships. Don't throw away any books; they all can be used down the road,

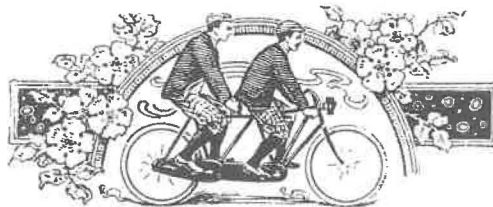
The UWC Book Sale Committee is so full of talent and enthusiasm they have planned not one, but TWO fund raising events for the Club's 1996-97 season.
